


NOTICE OF MEETING

The Board of Directors of Fort Bend County Municipal Utility District No. 163 will hold a regular meeting on **Tuesday, April 28, 2026**, at **9:30 a.m.**, at the offices of Allen Boone Humphries Robinson LLP, 3200 Southwest Freeway, **Suite 2400, San Bernard Room**, Houston, Texas, to discuss and, if appropriate, act upon the following items:

1. Comments from the public.
2. Approve minutes.
3. Terminate Municipal Advisory Services Agreement with Robert W. Baird & Co. Incorporated and engage Cedar Creek Municipal Advisors, LLC as the District's Financial Advisor.
4. Financial and bookkeeping matters, including payment of the bills and review of investments.
5. Tax collection matters.
6. Mowing and maintenance of District property.
7. Engineering matters, including authorize design, approve plans and specifications, authorize advertisement for bids, award contracts, and approve pay estimates, change orders, and final acceptance, for construction of District facilities, including:
 - a. Sanitary Lift Station for Katy Boardwalk Reserve;
 - b. Water, Sewer, Drainage, and Paving - Phase 1 for Katy Boardwalk Reserve; and
 - c. deeds, easements, or consents to encroachment.
8. Update on 46-acre annexation and related matters, and authorize appropriate action, including:
 - a. approve feasibility study;
 - b. accept Petition for Addition of Certain Land;
 - c. authorize execution of Development Financing Agreement, if appropriate; and
 - d. authorize execution of maintenance agreement with homeowner association for detention pond.
9. Attorney's report, including Resolution Requesting Harris County Appraisal District Activation of District.
10. Website matters.
11. Reports from directors and consultants on District matters.
